

**SAN JUAN RIVER OUTFITTERS AND LIVERY CO.

New Mexico Department of Game and Fish regulations require that this contract be signed and one copy returned to San Juan River Outfitters if you apply for any draw hunt using our outfitter number (0-1955). Use of this number on your application ensures your entry will be processed through the outfitter pool and your odds of drawing may be increased. You are, by use of this number, agreeing to use our services in, at a minimum, one of the hunt packages outlined below.

Hunt Package	San Juan River Outfitters and Livery Co. Will Provide:	Typical Rate per Hunter*
"Drop Camp"	Fully equipped camp; tents and shelter, bedding, water, firewood (or heating gas), lighting, cook stove, utensils, and all camp gear. Our tents are heated with wood stoves and a camp shower and latrine facilities are provided. (Pre-cooked frozen meals, and groceries can also be provided for an additional fee.) You are required only to bring your own food, soft drinks, personal clothing and hunting gear. Many of our hunters bring their own sleeping bag, but it's not required if you're traveling light. We provide clean warm bedding. The main difference between these drop camps and our "Outfitted" camps is that these camps are largely unattended by our staff and camp livestock, You're on your own for your hunt, and you will do your own meal preparation. The equipment and accommodations are of the same high quality as our attended camps.	\$1250 +sales tax
